R/Sir,

MIL HQ had issued Store Purchase Manual wef 1st Oct. 2021 to the all units under MIL. Meeting of Board of directors were held on 17.05.2022 to discuss about guidelines issued by Government of India regarding procurement of goods & services by government organisations.

As decided by the Board of the Company, following amendments are hereby made in Store Purchase Manual 2021:

Addition of Clause 2.19 (d):

- (i) The products developed by any innovator/Startup/Company under iDEX initiatives need to be treated at par with Proprietary sources and taken up for procurement under that category. In case more than one innovator/Startup/Company has accepted the challenge and accomplished the same, the procurement would be done on limited tender basis restricting the tender to such successful innovator / start-up / company.
- (ii) On successful development of the prototype, the procurement avenues should not be restrictive. The procurement should be possible by other entities including DPSUs, other establishments within MoD or external to MoD.
